Fair Housing Ordinance #031423

AN ORDINANCE TO CREATE SECTION __#1.0__ OF THE MUNICIPAL CODE OF THE TOWN OF SILVER CLIFF FAIR HOUSING ORDINANCE ADOPTING WISCONSIN STATUTES, SECTION 106.50, AS AMENDED, RELATING TO THE EQUAL RIGHTS OF ALL PERSONS TO FAIR HOUSING, AND PROVIDING MEANS FOR THE IMPLEMENTATION AND ENFORCEMENT THEREOF.

THE TOWN BOARD OF THE TOWN OF SILVER CLIFF DOES ORDAIN AS FOLLOWS:

Section 1 of the Town of Silver Cliff Fair Housing Ordinance is created to read as follows:

FAIR AND OPEN HOUSING

WHEREAS, the Town of Silver Cliff recognizes its responsibilities under Section 106.50, Wisconsin Statutes, as amended, and endorses the concepts of fair and open housing for all persons and prohibition of discrimination therein;

THEREFORE, BE IT ORDAINED THAT:

- 1) The Town of Silver Cliff hereby adopts Section 106.50, Wisconsin Statutes, as amended, and all subsequent amendments thereto.
- 2) The officials and employees of the Town of Silver Cliff shall assist in the orderly prevention and removal of all discrimination in housing within the Town municipal jurisdiction by implementing the authority and enforcement procedures set forth in Section 106.50, Wisconsin Statutes, as amended.

3) The Municipal Clerk shall maintain forms for complaints to be filed under Section 106.50, Wisconsin

Statutes, as amended, and shall assist any person alleg complaint thereunder with the Wisconsin Department of enforcement of Section 106.50, Wisconsin Statutes, as	Work Force Development Faual Rights Division for
